Sedation for 8:30AM

Your (Son/Daughter) is scheduled for MRI with sedation.

You and your child should arrive in the Outpatient Registration Department by 7:15AM.

Please Park in the South Parking Garage. Come in the South Entrance of the Hospital. Go to the Outpatient Registration desk. After you are registered you will be escorted to the Pediatric Special Procedure Area and will be greeted by one of the RN's.

Do not give your child anything to eat or drink after midnight.

Your child will be assessed by one of the sedation nurses and one of our pediatric hospitalists (an in house pediatrician). You will need to fill out a MRI screening form. You will also be asked to sign a consent for the procedure and another one for the sedation. An anesthesiologist will talk to you and answer any questions you have about the sedation prior to the procedure.

Please dress your child in comfortable clothes with no metal or metallic designs. No jewelry (earrings, necklaces, watch, etc.). No hair decoration for the girls.

Please make sure that you bring the order for the test prescribed to you by your physician.

After the procedure is completed and your child is awake, he/she will be given a snack. Discharge instructions will be given.

If you would like a copy of your MRI on a disk please let your RN know prior to your test so we can get the authorization forms filled out and have your disk ready prior to discharge.
